



Credit Card Installment Agreement: (For Renewing Primary Members Only) Due By 08/22/2025

2026 Membership Dues are due no later than December 31, 2025. Metro South Association of REALTORS® offers all renewing primary members the opportunity to participate in a 3-part installment agreement, with installment fees, as an alternative to paying membership dues in one payment. If you elect to participate in this plan, MSAR will send you a link to provide your credit/debit card information within our secured system. When each installment is due, your payment method on-file will be auto-drafted for the total amount of each of the three installments and their corresponding installment fee of \$5. For members who do not participate in the installment plan, dues will be paid via one invoice no later than December 31st, 2025.
